AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT, made and entered into by and between the **CITY OF ATLANTIC CITY**, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "**CITY**", and **PRIMEPOINT, LLC** with offices located at 2 Springside Road, Westampton, New Jersey 08060, hereinafter referred to as "**CONSULTANT**", pursuant to Resolution No. 580 adopted by the Council of the **CITY** on August 20, 2025, a copy of which is attached hereto and made a part hereof.

WHEREAS, by Resolution No. 652 adopted September 18, 2024, the City exercised its second one-year option to extend the Agreement with **CONSULTANT FOR PROFESSIONAL MUNICIPAL PAYROLL SERVICES** in the amount of **ONE HUNDRED SIXTEEN THOUSAND ONE HUNDRED EIGHTY-EIGHT DOLLARS AND THIRTY CENTS (\$116,188.30)**; and

WHEREAS, by Resolution 188 adopted March 19, 2025, additional funds were needed for **2024 MUNICIPAL PAYROLL SERVICES** in the amount of **TWELVE THOUSAND NINE HUNDRED EIGHTY DOLLARS AND EIGHTY-FIVE CENTS (\$12,980.85)** to be known as **AMENDATORY AGREEMENT No. 1.**

WHEREAS, additional funds are needed for **2025 MUNICIPAL PAYROLL SERVICES** in the amount of **TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00)**, to be known as **AMENDATORY AGREEMENT NO. 2.**

WHEREAS, with the exception of the modifications contained herein, all other terms, conditions and provisions of the Agreement between the parties shall remain in full force and effect.

NOW, THEREFORE, BE IT RESOLVED in consideration of the mutual covenants contained herein, the parties agree that the Agreement authorized by Resolution No. 652 adopted by the Council of the **CITY** on September 18, 2024, is hereby amended to include the above referenced

additional funds and services in the amount of **TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00)** to be known as **AMENDATORY AGREEMENT No. 2.**

CONSULTANT represents that it is in compliance with all laws of the State of New Jersey, all Ordinances of the City of Atlantic City, including Ordinance No. 24 of 1993, and Executive Order No. 1 of 1993, attached hereto and made a part hereof, involving Affirmative Action and minority business participation and will remain so for the term of this Agreement and Amendatory Agreement No.2, and failure to continue in compliance shall be deemed a breach of the Agreement and this Amendatory Agreement No. 2.

CONSULTANT cannot assign its rights or obligations under the Agreement without the prior written consent of the **CITY.**

The Amendatory Agreement No.2 is effective as of the date of the complete execution.

RESOLUTION AUTHORIZING AN AMENDATORY AGREEMENT WITH PRIMEPOINT, LLC, FOR ADDITIONAL FUNDS NEEDED FOR 2025 MUNICIPAL PAYROLL SERVICES IN THE AMOUNT OF \$25,000

WHEREAS, the City of Atlantic City, pursuant to Resolution 513 adopted on October 20, 2020, entered into a contract with **PRIMEPOINT, LLC** for **PROFESSIONAL MUNICIPAL PAYROLL SERVICES** for a period of three (3) years with an option of two (2) one (1) year extensions; and

WHEREAS, by Resolution 696 adopted on September 20, 2023 the City of Atlantic City exercised its first one (1) year option provision and extended the contract with **PRIMEPOINT, LLC** from October 1, 2023 to September 30, 2024 in the amount of **ONE HUNDRED SIXTEEN THOUSAND ONE HUNDRED EIGHTY-EIGHT DOLLARS AND THIRTY CENTS (\$116,188.30)**; and

WHEREAS, by Resolution 652 adopted on September 18, 2024 the City of Atlantic City exercised its second one (1) year option provision extended the contract with **PRIMEPOINT, LLC** from October 1, 2024, to September 30, 2025 in the amount of **ONE HUNDRED SIXTEEN THOUSAND ONE HUNDRED EIGHTY-EIGHT DOLLARS AND THIRTY CENTS (\$116,188.30)**; and

WHEREAS, by Resolution 188 adopted March 19, 2025 additional funds were needed for **2024 MUNICIPAL PAYROLL SERVICES** in the amount of **TWELVE THOUSAND NINE HUNDRED EIGHTY DOLLARS AND EIGHTY-FIVE CENTS (\$12,980.85)** known as **AMENDATORY AGREEMENT No. 1.**; and

WHEREAS, additional funds are needed for **2025 MUNICIPAL PAYROLL SERVICES** in the amount of **TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00)**, to be known as **AMENDATORY AGREEMENT NO. 2.**

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Atlantic City that the Mayor is hereby authorized to execute and the City Clerk to attest to an **AMENDATORY AGREEMENT** with **PRIMEPOINT, LLC** for **ADDITIONAL 2025 MUNICIPAL PAYROLL SERVICES** to be known as an **AMENDATORY AGREEMENT NO. 2**; and

BE IT FURTHER RESOLVED that a Certificate from the Chief Financial Officer is attached to this Resolution, showing the availability of funds from Account No. 5-01-20-132-200-294, and specifying the line-item appropriation from the 2025 Budget to satisfy the aforesaid.
