

AMENDATORY AGREEMENT NO. 2

THIS AMENDATORY AGREEMENT, made and entered into by and between the **CITY OF ATLANTIC CITY**, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "**CITY**", and **TIMOTHY C. REED, ESQ.** with offices located at 140 E. Revere Avenue, Northfield, NJ 08225 hereinafter referred to as "**COUNSEL**", pursuant to Resolution No. 609 adopted by the Council of the **CITY** on August 20, 2025, a copy of which is attached hereto and made a part hereof.

WHEREAS, by Resolution No. 918 of December 18, 2024, the **CITY** entered into an Agreement with **COUNSEL TO ACT AS ASSISTANT MUNICIPAL PROSECUTOR** in the amount of **THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00)**; and

WHEREAS, by Resolution No. 274 of April 16, 2025, it was necessary for **COUNSEL TO PROVIDE ADDITIONAL SESSIONS AS ASSISTANT MUNICIPAL PROSECUTOR** for an additional amount of **THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00)** known as **AMENDATORY AGREEMENT NO. 1**; and

WHEREAS, it is again necessary for **COUNSEL TO PROVIDE ADDITIONAL SESSIONS AS ASSISTANT MUNICIPAL PROSECUTOR** for an additional amount of **FORTY THOUSAND DOLLARS (\$40,000.00)** to be known as **AMENDATORY AGREEMENT NO. 2**; and

WHEREAS, with the exception of the modifications contained herein, all other terms, conditions, and provisions of the Agreement between the parties shall remain in full force and effect.

NOW, THEREFORE, BE IT RESOLVED in consideration of the mutual covenants contained herein, the parties agree that the Agreement authorized by Resolution No. 918 adopted by the Council of the **CITY** on December 18, 2024, is hereby amended to include the above referenced additional sessions in the amount of **FORTY THOUSAND DOLLARS (\$40,000.00)** for a new total not to exceed **ONE HUNDRED TEN THOUSAND DOLLARS (\$110,000.00)** to be known as **AMENDATORY AGREEMENT No. 2**.

COUNSEL represents that it is in compliance with all laws of the State of New Jersey, all Ordinances of the City of Atlantic City, including Ordinance No. 24 of 1993, Executive Order No. 1 of 1993, and will remain so for the term of this Agreement and Amendatory Agreement No. 2, and failure to continue in compliance shall be deemed a breach of the Agreement and this Amendatory Agreement No. 2.

COUNSEL cannot assign its rights or obligations under the Agreement without the prior written consent of the CITY.

Amendatory Agreement No. 2 is effective as of the date of complete execution hereof.





**RESOLUTION AUTHORIZING AN AMENDATORY AGREEMENT WITH
TIMOTHY C. REED, ESQ. - ASSISTANT MUNICIPAL PROSECUTOR FOR ADDITIONAL SERVICES
AND PAYMENT FOR 2025 IN THE AMOUNT OF \$40,000.00**

WHEREAS, the City of Atlantic City, pursuant to Resolution 918 adopted on December 18, 2024, entered into a contract with **TIMOTHY C. REED, ESQ.**, to act as Assistant Municipal Prosecutor for the City for a period of one (1) year from January 1, 2025 through December 31, 2025 in the amount of **THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00)**; and

WHEREAS, it was necessary to have **TIMOTHY C. REED, ESQ.**, provide additional sessions as Assistant Municipal Prosecutor and therefore additional funds are needed for his services in the amount of **THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00)** for a new total not to exceed **SEVENTY THOUSAND DOLLARS (\$70,000.00)** to be known as **AMENDATORY AGREEMENT No. 1.**

WHEREAS, it is again necessary to have **TIMOTHY C. REED, ESQ.**, provide additional sessions as Assistant Municipal Prosecutor and therefore additional funds are needed for his services in the amount of **FORTY THOUSAND DOLLARS (\$40,000.00)** for a new total not to exceed **ONE HUNDRED TEN THOUSAND DOLLARS (\$110,000.00)** to be known as **AMENDATORY AGREEMENT No. 2.**

NOW, THEREFORE, BE RESOLVED by the Council of the City of Atlantic City that the Mayor is hereby authorized to execute and the City Clerk to attest to an **AMENDATORY AGREEMENT** with **TIMOTHY C. REED, ESQ.** for additional services in the amount of **FORTY THOUSAND DOLLARS (\$40,000.00)** to be known as **AMENDATORY AGREEMENT No. 2;** and

BE IT FURTHER RESOLVED that a Certificate from the Chief Financial Officer is attached to this Resolution, showing the availability of funds specifying the line-item appropriation from the 2025 Budget to satisfy the aforesaid.
