

AMENDATORY AGREEMENT NO. 1

THIS AMENDATORY AGREEMENT, made and entered into by and between the **CITY OF ATLANTIC CITY**, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "**CITY**", a **AFFANATO MARUT, LLC** with offices located at Marlton Pike, K-54, Cherry Hill, New Jersey 08003 hereinafter referred to as "**COUNSEL**", pursuant to Resolution No. 691 adopted by the Council of the **CITY** on October 22, 2025, a copy of which is attached hereto and made a part hereof.

WHEREAS, by Resolution No. 862 of December 18, 2024, the **CITY** entered into an Agreement with **COUNSEL** for **WORKERS' COMPENSATION COUNSEL SERVICES** in the amount of **ONE HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$125,000.00)** ; and

WHEREAS, it is necessary to add **ADDITIONAL WORKERS' COMPENSATION COUNSEL SERVICES** in the amount of **THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00)** to be known as **AMENDATORY AGREEMENT NO. 1**; and

WHEREAS, with the exception of the modifications contained herein, all other terms, conditions, and provisions of the Agreement between the parties shall remain in full force and effect.

NOW, THEREFORE, BE IT RESOLVED in consideration of the mutual covenants contained herein, the parties agree that the Agreement authorized by Resolution No. 862 adopted by the Council of the **CITY** on December 18, 2024, is hereby amended to include the above referenced additional work outlined in Resolution No. 691 adopted by Council on October 22, 2025 in the amount of **THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00)** for a new total not to exceed **ONE HUNDRED SIXTY THOUSAND DOLLARS (\$160,000.00)** to be known as **AMENDATORY AGREEMENT No. 1**.

COUNSEL represents that it is in compliance with all laws of the State of New Jersey, all Ordinances of the City of Atlantic City, including Ordinance No. 24 of 1993, Executive Order No. 1 of 1993, and will remain so for the term of this Agreement and Amendatory Agreement No. 1, and failure to

continue in compliance shall be deemed a breach of the Agreement and this Amendatory Agreement No.

1.

COUNSEL cannot assign its rights or obligations under the Agreement without the prior written consent of the CITY.

Amendatory Agreement No.1 is effective as of the date of complete execution hereof.



RESOLUTION AUTHORIZING AN AMENDATORY AGREEMENT FOR AFFANATO & MARUT, LLC IN THE AMOUNT OF \$35,000.00

WHEREAS, by Resolution No. 862 of December 18, 2024, the City of Atlantic City entered into an Agreement with **AFFANATO & MARUT, LLC FOR WORKERS' COMPENSATION MATTERS** in the amount of **ONE HUNDRED TWENTY-FIVE THOUSAND DOLLARS (\$125,000.00)** from **JANUARY 1, 2025**, through **DECEMBER 31, 2025**; and

WHEREAS, there is a need for **ADDITIONAL WORKERS' COMPENSATION MATTERS** in the amount of **THIRTY-FIVE THOUSAND (\$35,000.00)** for a new total not to exceed **ONE HUNDRED SIXTY THOUSAND DOLLARS (160,000.00)**; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Atlantic City that the Mayor is hereby authorized to execute and the City Clerk to attest to an **AMENDATORY AGREEMENT** in the amount of **THIRTY-FIVE THOUSAND DOLLARS (\$35,000.00)** for a new total not to exceed **ONE HUNDRED SIXTY THOUSAND DOLLARS (160,000.00)** for the aforementioned services to be known as **AMENDATORY AGREEMENT No. 1**.

BE IT FURTHER RESOLVED that a Certificate from the Chief Financial Officer is attached to this Resolution, showing the availability of funds and specifying the line-item appropriation from the 2025 Budget to satisfy the aforesaid.
