

AMENDATORY AGREEMENT NO. 1

THIS AMENDATORY AGREEMENT, made and entered into by and between the **CITY OF ATLANTIC CITY**, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "**CITY**", and **THINK PAVERS HARDSCAPING, LLC.**, with offices located at 44 Cooper Street, Woodbury, New Jersey 08096, hereinafter referred to as the "**CONTRACTOR**", pursuant to Resolution No. 152 adopted by the Council of the **CITY** on February 18, 2026, a copy of which is attached hereto and made a part hereof.

WHEREAS, by Resolution No. 636 adopted September 17, 2025, the City of Atlantic City entered into an Agreement with Contractor for **ALBANY AVENUE & CROSSON AVENUE INTERSECTION SAFETY IMPROVEMENTS** for the City in the amount of **ONE HUNDRED SIXTEEN THOUSAND NINE HUNDRED EIGHTY-ONE DOLLARS (\$116,981.00)**; and

WHEREAS, by Resolution No. 152 adopted February 18, 2026, it is necessary to **EXTEND THE CONTRACT BY 104 CALENDAR DAYS FOR MILLING AND PAVING (NEW QUANTITY 222 SY @ \$57.43)** outside of the original scope of contract **AT NO ADDITIONAL COST** to be known as **AMENDATORY AGREEMENT No. 1**.

WHEREAS, with the exception of the modifications contained herein, all other terms, conditions and provisions of the Agreement between the parties shall remain in full force and effect.

NOW, THEREFORE, BE IT RESOLVED in consideration of the mutual covenants contained herein, the parties agree that the Agreement authorized by Resolution No. 636 adopted by the Council of the **CITY** on September 17, 2025, is hereby amended to include the above referenced section to **EXTEND THE CONTRACT BY 104 CALENDAR DAYS FOR MILLING AND PAVING (NEW QUANTITY 222 SY @ \$57.43)** outside of the original scope of contract **AT NO ADDITIONAL COST** to be known as **AMENDATORY AGREEMENT No. 1**.


CONTRACTOR represents that it is in compliance with all laws of the State of New Jersey, all Ordinances of the City of Atlantic City, including Ordinance No. 24 of 1993, and Executive Order No. 1

of 1993, involving Affirmative Action and minority business participation and will remain so for the term of this Agreement and Amendatory Agreement No. 1, and failure to continue in compliance shall be deemed a breach of the Agreement and this Amendatory Agreement No. 1.


CONTRACTOR cannot assign its rights or obligations under the Agreement without the prior written consent of the CITY.

The Amendatory Agreement No. 1 is effective as of the date of complete execution hereof.



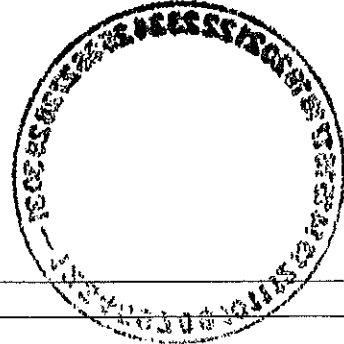
RESOLUTION AWARDING AN AMENDATORY AGREEMENT TO THINK PAVERS HARDSCAPING, LLC, GRANTING AN EXTENSION OF TIME IN THE AMOUNT OF ONE HUNDRED FOUR (104) CALENDAR DAYS

WHEREAS, by Resolution No. 636 of September 17, 2025, the City of Atlantic City entered into an Agreement with THINK PAVERS HARDSCAPING, LLC for ALBANY AVENUE & CROSSON AVENUE INTERSECTION SAFETY IMPROVEMENTS for a total delivered sum of ONE HUNDRED SIXTEEN THOUSAND NINE HUNDRED EIGHTY-ONE DOLLARS (\$116,981.00); and

WHEREAS, it is necessary to extend the contract 104 calendar days for MILLING AND NEW QUANTITY at no additional cost to be known as AMENDATORY AGREEMENT NO. 1.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of Atlantic City that the Mayor is hereby authorized to execute and the City Clerk to attest to an AMENDATORY AGREEMENT with THINK PAVERS HARDSCAPING, LLC at no additional cost for the aforementioned change of scope of work to be known as AMENDATORY AGREEMENT NO. 1.
