**AMENDATORY AGREEMENT NO. 1**

**THIS AMENDATORY AGREEMENT**, made and entered into by and between the **CITY OF ATLANTIC CITY**, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "**CITY**", and the **LAW OFFICE OF DANIEL J. GALLAGHER, ESQUIRE**, with offices located at 336 N. Annapolis Avenue, Atlantic City, NJ 08401, hereinafter referred to as "**COUNSEL**", pursuant to Resolution No. 341 adopted by the Council of the CITY on May 13, 2026, a copy of which is attached hereto and made a part hereof.

**WHEREAS**, by Resolution No. 834 adopted on December 17, 2025, the **CITY** entered into an Agreement with the **LAW OFFICE OF DANIEL J. GALLAGHER, ESQUIRE**, for Legal Services in the amount of **ONE HUNDRED SEVENTY-FIVE THOUSAND DOLLARS (\$175,000.00)**; and

**WHEREAS**, it is in the best interest of the City of Atlantic City to ensure fair and competitive compensation for legal services by raising the rate from \$130.00 per hour to \$185.00 per hour to maintain the quality and effectiveness of its legal representation in all matters and therefore, by Resolution No. 341 adopted May 13, 2026, the City has increased the hourly rate for legal services to **ONE HUNDRED EIGHTY-FIVE DOLLARS (\$185.00)** per hour to be known as **AMENDATORY AGREEMENT NO. 1**; and

**WHEREAS**, with the exception of the modifications contained herein, all other terms, conditions and provisions of the Agreement between the parties shall remain in full force and effect.

**NOW, THEREFORE, BE IT RESOLVED** in consideration of the mutual covenants contained herein, the parties agree that the Agreement authorized by Resolution No. 834 adopted

by the Council of the CITY on December 17, 2025, is hereby amended to include the above referenced rate increase approved by Resolution No. 341 adopted by Council on May 13, 2026, to be known as **AMENDATORY AGREEMENT NO. 1**.

**COUNSEL** represents that it is in compliance with all laws of the State of New Jersey, all Ordinances of the City of Atlantic City, including Ordinance No. 24 of 1993, Executive Order No. 1 of 1993, and will remain so for the term of this Agreement and Amendatory Agreement No. 1, and failure to continue in compliance shall be deemed a breach of the Agreement and this Amendatory Agreement No. 1.

**COUNSEL** cannot assign its rights or obligations under the Agreement without the prior written consent of the CITY.

The Amendatory Agreement No.1 is effective as of the date of April 23, 2026.

### RESOLUTION AMENDING THE AGREEMENT WITH THE LAW OFFICE OF DANIEL J. GALLAGHER TO INCREASE LEGAL FEES FROM \$130.00 PER HOUR TO \$185.00 PER HOUR

WHEREAS, the City of Atlantic City entered into an agreement via Resolution No. 834 of 2025 with the LAW OFFICE OF DANIEL J. GALLAGHER which compensates the LAW OFFICE OF DANIEL J. GALLAGHER, at a rate of \$130.00 per hour; and

WHEREAS, it is in the best interest of the City of Atlantic City to ensure fair and competitive compensation for legal services by raising the rate from \$130.00 per hour to \$185.00 per hour to maintain the quality and effectiveness of its legal representation in all matters; and

WHEREAS, this new rate of \$185.00 per hour shall apply to all new and ongoing matters as assigned and all other terms and conditions of the Agreement will remain unchanged.

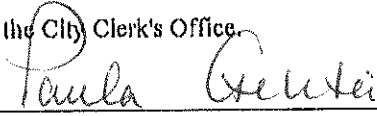
NOW, THEREFORE, BE IT RESOLVED the hourly rate for the LAW OFFICE OF DANIEL J. GALLAGHER, providing Legal Services to the City of Atlantic City pursuant to the agreement approved by Resolution No. 834 of 2025, shall increase from ONE HUNDRED THIRTY DOLLARS (\$130.00) PER HOUR TO ONE HUNDRED EIGHTY-FIVE DOLLARS (\$185.00) PER HOUR.

BE IT FURTHER RESOLVED, that City Solicitor is hereby authorized to implement this change and take all actions necessary to notify outside counsel and update any relevant contracts or billing procedures accordingly.
