CONTRACT EXTENSION

THIS CONTRACT EXTENSION, made and entered into by and between the CITY OF ATLANTIC CITY, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "CITY", and BOARDWALK TRANSPORTATION, LLC with offices located at 114 South New York Avenue, Atlantic City, New Jersey 08401, hereinafter called "CONTRACTOR", pursuant to Resolution No. 430 adopted by the Council of the CITY on June 18, 2025, a copy of which is attached hereto and made a part hereof.

WHEREAS, the CITY and CONTRACTOR entered into an Agreement authorized by Resolution No. 43 of 2021 TO PROVIDE THE CITY WITH MOTORIZED TRAM SERVICES ON THE ATLANTIC CITY BOARDWALK for a three (3) year period, with the option to extend for two (2) additional one (1) year periods (each, an "Option Period"), at the sole discretion of the City; and

WHEREAS, it is necessary and in the City's best interest to exercise the second option period of the Agreement for the one (1) year extension from March 1, 2025 through February 28, 2026 (the "Extension"); and

WHEREAS, with the exception of the modifications contained herein, all other terms, conditions and provisions of the Agreement between the parties shall remain in full force and effect.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City, the Mayor or his designee is hereby authorized to execute and the City Clerk to attest to the Extension, to be approved as to form by the City Solicitor, between the CITY and BOARDWALK TRANSPORTATION, LLC for the second one (1) year extension from March 1, 2025 through February 28, 2026.

CONTRACTOR represents that it is in compliance with all laws of the State of New Jersey, all Ordinances of the City, including Ordinance No. 24 of 1993, Executive Order No. 1 of 1993, and will remain so for the term of this Agreement and the Extension and failure to continue in compliance shall be deemed a breach of this Agreement and the Extension.

CONTRACTOR cannot assign its rights or obligations under this Agreement without the prior written consent of the CITY.

This Extension is effective as of the date of complete execution hereof.

RESOLUTION TO EXERCISE SECOND ONE YEAR OPTION TO EXTEND CONTRACT WITH BOARDWALK TRANSPORTATION, LLC FOR MOTORIZED TRAM SERVICES ON THE ATLANTIC CITY BOARDWALK FROM MARCH 1, 2025 THROUGH FEBRUARY 28, 2026

WHEREAS, by Resolution 43 of 2021 the City accepted the bid of **BOARDWALK TRANSPORTATION, LLC** a corporation of the State of New Jersey, with offices located at 114 S. New York Avenue, Atlantic City, New Jersey 08401, **TO PROVIDE THE CITY OF ATLANTIC CITY WITH MOTORIZED TRAM SERVICES ON THE ATLANTIC CITY BOARDWALK**, subject to the approvals and insurance requirements, for a three (3) year period with two one (1) year options to extend at the discretion of the City, with current contract terms; and subject to the approvals and insurance requirements; and

WHEREAS, it is necessary and in the best interest of the City to exercise the second one (1) year option provision of the contract and extend the contract commencing March 1, 2025 through February 28, 2026.

NOW, THEREFORE, **BE IT RESOLVED** the City Council of the City of Atlantic City is authorizing the Mayor to execute and the City Clerk to attest to an agreement exercising the second one (1) year option provision of the agreement entered into between the City of Atlantic City and **BOARDWALK TRANSPORTATION, LLC TO PROVIDE MOTORIZED TRAM SERVICES ON THE ATLANTIC CITY BOARDWALK** in compliance with the Advertisement, Proposal Form, and the Specifications and Instructions to bidders therefore, approved and adopted by the City Council, said agreement to be approved as to form and execution by the City Solicitor.
