## AMENDATORY AGREEMENT NO. 1

**THIS AMENDATORY AGREEMENT**, made and entered into by and between the **CITY OF ATLANTIC CITY**, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "**CITY**", and **BLANEY, DONOHUE, & WEINBERG, P.C.** with offices located at 2123 Dune Drive, Suite 11, Avalon, NJ 08202, hereinafter referred to as "**COUNSEL**".

**WHEREAS**, by Resolution No. 840 adopted December 18, 2024, the **CITY** entered into an Agreement with **COUNSEL**, to provide representation for **Labor & Municipal Defense Matters** for the City of Atlantic City, in the amount of TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00) at the hourly rate of \$130.00 per hour, commencing January 1, 2025 through December 31, 2025; and

**WHEREAS**, it is in the best interest of the City to ensure fair and competitive compensation for legal services to maintain quality and effective legal representation during labor negotiations; and

**WHEREAS**, the City believes that in order to facilitate such fair and competitive compensation and effective legal service it is necessary to increase the hourly rate for legal services for **LABOR MATTERS** provided by **COUNSEL** from \$130.00 per hour to \$185.00 per hour, to be known as **AMENDATORY AGREEMENT NO. 1**; and

**WHEREAS**, with the exception of the modifications contained herein, all other terms, conditions and provisions of the Agreement between the parties shall remain in full force and effect.

**NOW, THEREFORE, BE IT RESOLVED**, pursuant to Resolution No. 662 adopted on September 17, 2025 by Council of the City, the **HOURLY RATE** for **COUNSEL** for providing

legal services for **LABOR MATTERS** to the City shall be increased from **\$130.00 PER HOUR TO \$185.00 PER HOUR** and this rate shall apply to all new and ongoing labor negotiation matters from the date of execution of this Amendatory Agreement and all other terms and conditions of the Agreement will remain unchanged.

**COUNSEL** represents that it is in compliance with all laws of the State of New Jersey, all Ordinances of the City, including Ordinance No. 24 of 1993, and Executive Order No. 1 of 1993, and will remain so for the term of this Agreement and Amendatory Agreement No. 1, and failure to continue in compliance shall be deemed a breach of the Agreement and this Amendatory Agreement No. 1.

**COUNSEL** cannot assign its rights of obligations under the Agreement without the prior written consent of the **CITY**.

## RESOLUTION AMENDING THE AGREEMENT WITH BLANEY, DONOHUE & WEINBERG, PC TO INCREASE LEGAL FEES FROM \$130.00 PER HOUR TO \$185.00 PER HOUR FOR LABOR NEGOTIATIONS

**WHEREAS**, the City of Atlantic City currently compensates **BLANEY, DONOHUE & WEINBERG, PC** at a rate of \$130 per hour; and

**WHEREAS**, it is in the best interest of the City of Atlantic City to ensure fair and competitive compensation for legal services to maintain the quality and effectiveness of its legal representation during labor negotiations; and

**WHEREAS**, this rate shall apply to all new and ongoing labor negotiation matters as determined appropriate and all other terms and conditions of the agreement will remain unchanged.

**NOW, THEREFORE, BE IT RESOLVED** the hourly rate for **BLANEY, DONOHUE & WEINBERG**, providing Labor Matters Legal Services to the City of Atlantic City shall be \$130 per hour to \$185 per hour.

**BE IT FURTHER RESOLVED**, that City Solicitor is hereby authorized to implement this change and take all actions necessary to notify outside counsel and update any relevant contracts, agreements, or billing procedures accordingly
