

AGREEMENT EXTENSION NO.1

THIS AGREEMENT EXTENSION, made and entered into by and between the **CITY OF ATLANTIC CITY**, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "**CITY**", and **FOUNDATION RISK PARTNERS CORP. d/b/a FAIRVIEW INSURANCE AGENCY ASSOCIATES**, with offices located at 25 Fairview Avenue Verona, New Jersey 07044 hereinafter called "**CONSULTANT**", pursuant to Resolution No. 816 adopted by the Council of the **CITY** on November 12, 2025, copy of which is attached hereto and made a part hereof.

WHEREAS, the **CITY** and **CONSULTANT** entered into an Agreement authorized by Resolution No. 77 adopted on January 29, 2025, to **ACT AS BROKER OF RECORD AND TO PERFORM HEALTH INSURANCE BROKER & CONSULTANT SERVICES** for a period of one (1) year with an option of two (2) one (1) year extensions; and

WHEREAS, it is necessary and in the City's best interest to exercise the option provision of the Agreement for the first (1st) one (1) year extension from **JANUARY 1, 2026, THROUGH DECEMBER 31, 2026**, in the sum of **NINETY-SIX THOUSAND DOLLARS (\$96,000.00)** (the "Extension No. 1"); and

WHEREAS, with the exception of the modifications contained herein, all other terms, conditions and provisions of the Agreement between the parties shall remain in full force and effect.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City, the Mayor or his designee is hereby authorized to execute and the City Clerk to attest to Extension No. 1, to be approved as to form by the City Solicitor, between the City and **CONSULTANT** for a one (1)

CONSULTANT cannot assign its rights or obligations under the Agreement or this Extension No. 1 without the prior written consent of the CITY.

The Extension No. 1 is effective as of the date of complete execution hereof.

RESOLUTION TO EXERCISE THE FIRST ONE (1) YEAR OPTION TO EXTEND CONTRACT WITH FAIRVIEW INSURANCE AGENCY ASSOCIATES, INC. FOR HEALTH INSURANCE BROKER & CONSULTANT SERVICES IN THE AMOUNT OF \$96,000.00

WHEREAS, the City of Atlantic City, pursuant to Resolution 77 adopted on January 29, 2025, entered into a contract with **FOUNDATION RISK PARTNERS CORP. d/b/a FAIRVIEW INSURANCE AGENCY ASSOCIATES** to **ACT AS BROKER OF RECORD AND TO PERFORM HEALTH INSURANCE BROKER & CONSULTANT SERVICES** for a period of one (1) year with an option of two (2) one (1) year extensions; and

WHEREAS, it is necessary and in the best interest of the City to exercise the **FIRST ONE (1) YEAR OPTION** provision of the contract and extend the contract with current contract terms from **JANUARY 1, 2026 THROUGH DECEMBER 31, 2026** for **HEALTH INSURANCE BROKER & CONSULTANT SERVICES** in the amount of **NINETY-SIX THOUSAND DOLLARS (\$96,000.00)**.

NOW, THEREFORE, BE IT RESOLVED the Council of the City of Atlantic City is authorizing the Mayor to execute and the City Clerk to attest to an agreement exercising the **FIRST ONE (1) YEAR OPTION** provision of the agreement entered into between the City of Atlantic City and **FOUNDATION RISK PARTNERS CORP. d/b/a FAIRVIEW INSURANCE AGENCY ASSOCIATES** for **HEALTH INSURANCE BROKER & CONSULTANT SERVICES** in the amount of **NINETY-SIX THOUSAND DOLLARS (\$96,000.00)**, approved and adopted by the City Council, said agreement to be approved as to form and execution by the City Solicitor; and

BE IT FURTHER RESOLVED the Certificate from the Chief Financial Officer has been attached to this Resolution, showing the availability of funds from Account No. 6-01-23-220-100-290 to satisfy the aforesaid award of contract; and

BE IT FURTHER RESOLVED that pursuant to N.J.A.C. 5:30-14.5 the above Contract is contingent upon the availability of sufficient funds in the 2026 Temporary and Permanent Budgets, and State approval. In the event said funds are not appropriated for this Contract it will then become null and void; and

BE IT FURTHER RESOLVED , Public Notice of this Resolution shall be published in THE PRESS at least once pursuant to the requirements of N.J.S.A. 40A:11-1, et seq., as amended.
