CONTRACT EXTENSION

THIS CHANGE ORDER, made and entered into by and between the CITY OF ATLANTIC CITY, a municipal corporation of the State of New Jersey, with its principal offices located at 1301 Bacharach Boulevard, Atlantic City, New Jersey 08401, hereinafter referred to as "CITY", and GOLD MEDAL ENVIRONMENTAL OF NJ, INC., with offices located at 309 Salina Road, Sewell, New Jersey 08080 hereinafter called "CONTRACTOR", pursuant to Resolution No. 303 adopted by the Council of the CITY on June 17, 2020, copy of which is attached hereto and made a part hereof.

WHEREAS, the CITY and CONTRACTOR entered into an Agreement authorized by the Municipal Stabilization & Recovery Act ("MRSA"), N.J.S.A. 52:27BBBB-1, et seq., to provide SOLID WASTE AND RECYCLING COLLECTION SERVICES as set forth in advertised bid #16-20; and

WHEREAS, it is necessary and in the City's best interest to exercise the option provision of this contract for the first one (1) year extension of this contract beginning on August 1, 2020 and ending on July 31, 2021 in the sum of in the amount of TWO MILLION FOUR HUNDRED EIGHTY THOUSAND TWO HUNDRED THIRTY-THREE DOLLARS (\$2,480,233.00); and

WHEREAS, with the exception of the modifications contained herein, all other terms, conditions and provisions of the Agreement between the parties shall remain in full force and effect.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Atlantic City that the Mayor or his designee is hereby authorized to execute and the City Clerk to attest to an agreement, to be approved as to form by the City Solicitor, between the City of Atlantic City and GOLD MEDAL ENVIRONMENTAL OF NJ, INC. for a one (1) year extension to JULY 31, 2021.

CONTRACTOR represents that it is in compliance with all laws of the State of New Jersey, all Ordinances of the City of Atlantic City, including Ordinance No. 24 of 1993, Executive Order No. 1 of 1993, and Exhibit "A" attached hereto and made a part hereof, involving Affirmative Action and minority business participation and will remain so for the term of this Agreement, and failure to continue in compliance shall be deemed a breach of this Agreement.

CONTRACTOR cannot assign its rights or obligations under this Agreement without the prior written consent of the CITY.

The within Change Order is effective as of the date of the Mayor's signature.

## RESOLUTION TO EXERCISE YEAR ONE OF TWO YEAR CONTRACT EXTENSION OPTION FOR GOLD MEDAL ENVIRONMENTAL OF NJ, INC. FOR SOLID WASTE & RECYCLING COLLECTION SERVICES

WHEREAS, pursuant to the authority under the Municipal Stabilization & Recovery Act ("MRSA"), N.J.S.A. 52:27BBBB-1, et seq., the City of Atlantic City accepted the bid of **GOLD MEDAL ENVIRONMENTAL OF NJ, INC.**, a corporation of the State of New Jersey, with offices located at 1770 Hurffville Road, Sewell, New Jersey 08080, to provide **SOLID WASTE & RECYCLING COLLECTION SERVICES**, for a (3) year period from August 1, 2017 to July 31, 2020, with the option of (2) one year extensions at the discretion of the City, with current contract terms; and

WHEREAS, it is necessary and in the best interest of the City to exercise the option provision of the contract and extend the contract for the first one year option from August 1, 2020 to July 31, 2021.

FOR SOLID WASTE & RECYCLING COLLECTION SERVICES** in the sum of **TWO MILLION FOUR HUNDRED EIGHTY THOUSAND TWO HUNDRED TWENTY THREE DOLLARS (\$2,480,223.00)** in compliance with the Advertisement, Proposal Form, and the Specifications and Instructions to bidders therefore, approved and adopted by the City Council, said agreement to be approved as to form and execution by the City Solicitor.
