AN ORDINANCE AMENDING CHAPTER 57 OF THE CODE OF THE CITY OF ATLANTIC CITY WHICH REGULATES JOB TITLES WITHIN THE CITY GOVERNMENT

WHEREAS, the City Council of the City of Atlantic City finds that there is a need to amend Chapter 57 of the Code of the City of Atlantic City which regulates job titles within the City government; and

WHEREAS, the City Council of the City of Atlantic City recognizes that there may be a need to hire and/or promote; and

WHEREAS, the City of Atlantic City will make every effort to hire and/or promote from within.

BE IT ORDAINED by the City Council of the City of Atlantic City as follows:

SECTION 1. Chapter 57-15 Department of Human Resources shall be amended as follows:

DELETE: (A.) Office of the Director.

DELETE: (B.) Personnel Division.

DELETE: (C.) Health Division.

ADD: (A.) Office of the Director.
