Council Member ALL COUNCIL Presents the following Ordinance:

AN ORDINANCE TO AMEND ATLANTIC CITY CODE CHAPTER 209A-6 TO ESTABLISH FEES FOR THE ARENA NOW OWNED BY THE CITY OF ATLANTIC CITY

WHEREAS, the City has acquired the Bader Field Skate Zone property from the Casino Reinvestment Development Authority, (CRDA), and desires to amend its City Code to adopt fees for the facility.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Atlantic City that City Code Chapter 209A-6 Fees shall be amended as follows:

Section 1.

ADD:

G. Skate Zone

1. Exclusive Ice Rental
Parties \$400.00 per hour

2. Admission Fees for public skate

General Admission	\$10.00
Freestyle	\$15.00
Open Hockey	\$15.00
Skate Rental	\$4.00

3. Free admission for Atlantic City residents during designated Free Skate times.

4. Fees for Leagues, including practice and game ice, referee and tournament fees, and clinics will be determined on an annual basis.

- Section 2.** All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent necessary to remedy the inconsistency.
- Section 3.** The Business Administrator shall have the discretion to reduce all arena fees.
- Section 4.** This Ordinance shall become effective upon final passage and publication as provided by law.


